Traxon Global Customs recognizes and supports international standards including IATA CargoXML, UN, ASYCUDA and is aligned with the WCO Data Model

### The easy way to reduce declaration errors

The user platform works with a traffic light system that automatically alerts supply chain partners of any errors. If required, the message may be edited and a new message can be created and sent to customs. To ensure data correctness in all systems, the new message can be duplicated and sent as well to the cargo management system.

The application also translates customs' responses to the customers' own in-house systems via preferred protocols and alerts supply chain partners when further action is required. This makes the interface to customs simple, secure and seamless for the end user with a full audit trail of customs' reports and responses.

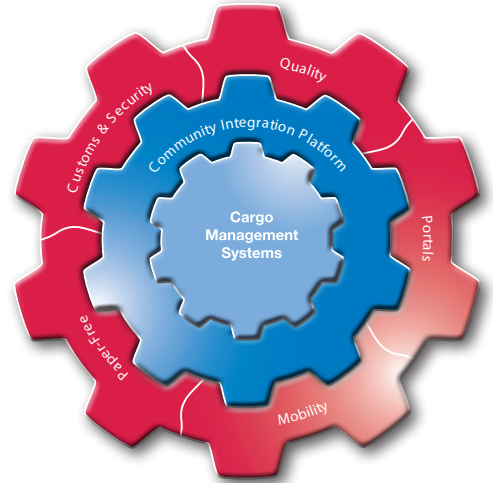

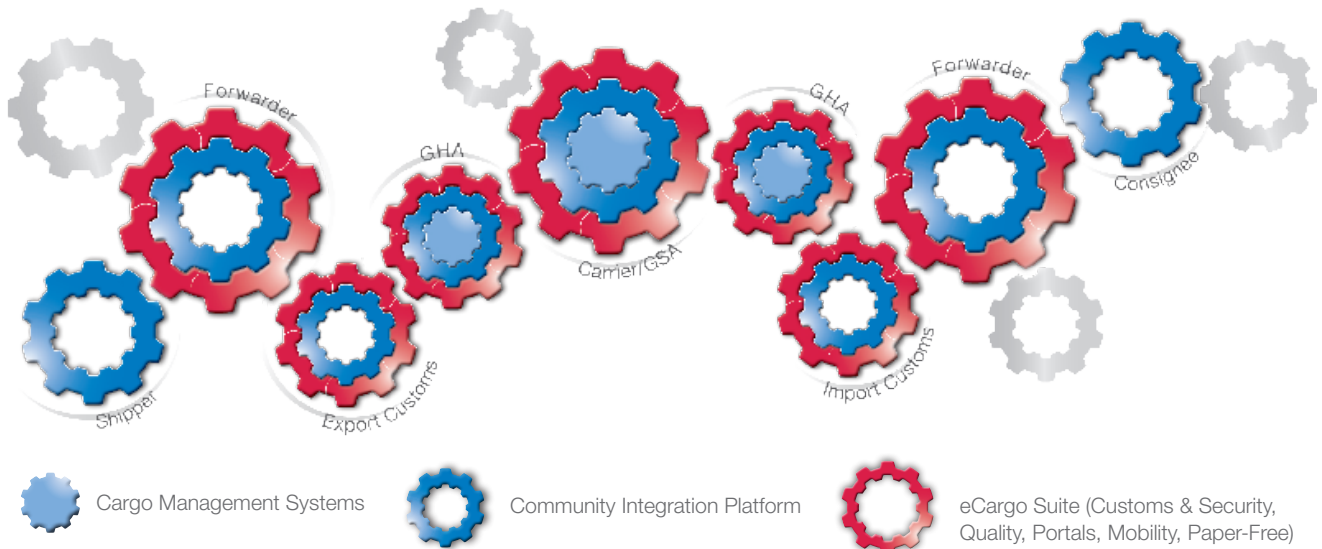
